SIGN THE WAIVER:

I hereby acknowledge that I have voluntarily applied to participate in dog agility training activities with Jean Hobbs, Mary Dincau and Fun Run Agility (hereinafter collectively called "the said parties". I am aware that there are inherent risks and hazards involved in activities with and around dogs and am voluntarily participating in these activities with knowledge of these potential dangers. I am not relying on the said parties to prevent such occurrences. In order to participate in dog agility training, I, being fully informed of such risks and hazards, agree to assume all risk of such occurrences.

I hereby waive any and all claims or actions I or my guardians, representatives or assignees may have against the said parties and agree to release the said parties from any and all personal injury to myself, my dog, children in my charge, or harm to property caused directly or indirectly by any acts that might occur in dog agility training, and further agree to indemnify, defend and hold the said parties harmless from any damage, loss, liability or expenses, including legal costs and attorney's fees, which result from damage caused by myself, children in my charge, or dog(s) I own or handle.

I hereby confirm that any dog I enter is at least one year old and has had a minimum of three months training on agility equipment.
